Executive Summary

The third phase of engagement captured an overwhelming level of community support for the renewal of Arthur Phillip Park, and confirmation that the three-phase engagement process has ensured that the draft Master Plan responded to community priorities.

Across the drop-in sessions, surveys, submissions and interviews, 97% of engagement participants expressed support for the draft Master Plan for Arthur Phillip Park, which included the proposed hierarchy of works, and relative timeframe for undertaking different aspects of the project.

Key findings

Along with capturing the community's level of support for the draft Master Plan, this final stage of engagement also looked to capture feedback on what elements of the design they believed were missing or could be improved to better respond to the community's needs or priorities. Congruent with the broad level of support for the plan, only one engagement participant highlighted an element that they felt was missing (the inclusion of a community hall/facility), while all other comments related to elements of the design that participants wanted to be more prevalent in the design, common suggestions included:

- The planting of more mature trees, beyond those that were already proposed in the draft Masterplan.
- The importance of inclusive and accessible spaces and materials throughout the park.
- The need for further consultation before beginning the regrading of sports fields.
- The importance of updating and implementing the traffic study findings.
- The inclusion of sport and recreational facilities for people of all ages.

How we engaged

The high level of support for the draft Masterplan, and the limited number of identified gaps, is a result of the extensive and genuine engagement that was undertaken during Phase 1 and Phase 2. This process encouraged the community to get involved, have their say, and play a leading role at key phases in the design process.

What we engaged on

Across all engagement methods (survey, interviews, drop-in sessions, and submissions), community members and stakeholders were asked to indicate whether they supported the draft Master Plan for Arthur Phillip Park, why that was the case, and whether they had any additional comments that may help shape the future of this important open space.











As previously noted, the draft Master Plan was the result of extensive previous engagement, and aimed to respond to community priorities and ideas that had been capture to date. As such, the phase three engagement also asked participants to reflect on whether they felt the plan effectively responded to what they had previously expressed, and/or the common community priorities that were presented in the Phase 1 and Phase 2 Engagement Outcomes Reports.

The following report provides a summary of the findings from the Phase 3 Engagement, along with a high-level overview of the key findings from earlier engagement phases.

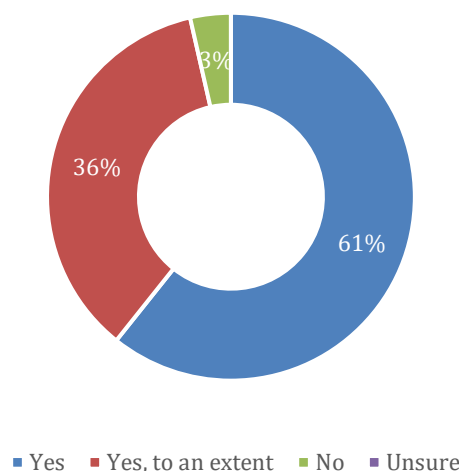

What we heard – Phase 3

Overall, engagement participants expressed a high level (97%) of support for the draft Master Plan for Arthur Phillip Park. Those participants who supported the draft Master Plan “To an extent” provided additional comments and feedback on how they felt it could be amended to better respond to community priorities and needs. All of these comments expressed a desire to see a particular element of the plan feature more prominently in the park, or its order changed in the hierarchy of works and the proposed relative time

The following pages discuss the key insights that were captured during the stakeholder interviews, written submission, and in the additional comments from survey participants.

The retention and planting of mature trees

The retention of all mature trees and the expansion of the tree canopy in Arthur Phillip Park was an element of the draft Master Plan that participants were delighted to see. The desire to see more planting of mature trees and greenery was the most common feedback captured in the Phase 3 Engagement – recommended by 7 separate participants.

In particular, participants expressed a desire for additional tree planting to take place along the walking path, highlighting that the draft Master Plan needed to further locate new planting along the Eastern Side of the park (to provide walking track users with shade from the Westerly Sun). A more detailed concept plan highlighting new trees will be provided following the masterplan adoption.

Furthermore, participants highlighted the current tree canopy over the play equipment as a key reason that they used the park, and wished to see this important part of the play space retained, irrespective of the upgrades that were planned. In addition to the natural shading provided by greenery, a number of survey respondents and in-park conversations reiterated the importance of the shrubbery and planting to create a natural barrier between the roadway and play equipment.

Parking for park users

Participants were encouraged to see Council had undertaken a traffic study to better understand the issues facing park users and neighbours who are affected by increased traffic and inability to park (acknowledged as not being due to park users). As the second most common comment captured during the final phase of engagement, participants wanted to see Council implement traffic and parking management measures that would accommodate park users for up to 4-6 hours, but not enable longer stays (most often undertaken by those travelling to the neighbouring hospital).

While this action was broadly supported by most engagement participants, the engagement captured two specific considerations for Council:

1. Participants did not wish to see metered parking at the park
2. Current parking structures and bollards were implemented to stop large trucks from parking across multiple spots overnight

Providing sports and recreational facilities for all

Creating sports and recreational opportunities for people of all ages and abilities was a common theme throughout all three phases of the engagement. However, phase three engagement participants felt that the site may hold additional sports and recreational facilities for young people.

Four separate survey participants simply highlighted the importance of the draft master plan's basketball and ping pong facilities to cater for older children and youth, while local sporting clubs questioned whether the Master Plan could consider the inclusion of more significant sporting facilities. The most common suggestion (made by two stakeholders from within the local cricket organisation) was to explore the possibility of including cricket nets in Arthur Phillip Park, that responds to the high demand for these assets across the LGA. Further to this, local soccer organisations acknowledged that upgrades to the sporting fields would enable them to make Arthur Phillip Park a significant location for their club's fixtures, and justify the club operating a canteen that would serve all weekend park users.

More broadly, engagement participants across all platform and activities acknowledged and reiterated the importance of inclusive design and the use of materials that would deliver spaces that are accessible for all members of the community.

Additional consideration for field regrading

The regrading of the sports fields was a particular point of interest for sporting groups and neighbouring residents (particularly those on the lower side of the park who may be affected by the inclusion of a retaining wall). Feedback on this element of the draft Master Plan was diverse; with sporting clubs recognising this element as being essential to them utilising the fields to their full capacity, and neighbouring residents expressing concern about the impact of the works.

Stakeholders from all local sporting organisations acknowledged the additional opportunities that a level playing field would present to use Arthur Phillip Park as a "home field" for more fixtures (be it soccer, cricket, rugby league or touch football). However, a number of these stakeholder did note that Arthur Phillip Park remains one of the few fields that are operational in wet weather, due to its exceptional drainage.

In contrast to this level of support for the regrading of the football fields, neighbouring residents (particularly those on the lower side of the park, whose outlook would be affected by any retaining wall), considered the slope to be of minimal impact on sporting fixtures, and that leaving the football fields untouched delivered the greatest benefit for the broader community.

Irrespective of their level of support for this element of the plan, participants wished to see further engagement carried out specifically on this aspect of the Master Plan, as it enters the planning and detailed design phase in the future.

The importance of amenities

There was a broad level of support for those elements of the design that enabled park users a more comfortable park experience. In particular, survey comments highlighted the importance of providing additional drinking fountains, retaining or upgrading the barbecue areas that are the location of many community gatherings, and ensuring adequate provision of bathrooms.

In regards to the current bathroom facilities, numerous drop-in session participants were of the (false) belief that the current toilets weren't often open and available for park users outside of sporting fixtures. Irrespective of whether this sentiment is incorrect or not, it was considered to be impacting the user experience of those who currently visit the park, and participants felt minor amendments, upgrades or signage would help users to understand the open hours of these facilities, and encourage greater use of the park.

Additional Ideas and Considerations

Whilst not common across the engagement, below is a list of additional ideas that were collected during the Phase 3 Engagement:

- Limiting change room upgrades to the current height of the existing building
- The inclusion of solar powered lighting in the park
- The inclusion of a community garden and or vegetable patch
- A desire for the entire project timeline to be delivered sooner
- The planting of native species throughout the park
- The inclusion of some tennis facilities, whether that be a court, mini-court or rebound call
- Including plans for a community facility, such as a hireable hall space within the Master Plan
- The waterplay was considered a capital-intensive inclusion that did not deliver appropriate social benefit

Where to from here

Following on from the Phase 1 and Phase 2 insights that helped shaped a draft Master Plan for Arthur Phillip Park, the design team will utilise the findings from this phase of engagement to refine the draft Master Plan before seeking endorsement from Councillors.

July 2021

A final version will be made publicly available and put forward to Council for adoption. The renewed 2021 masterplan for Arthur Phillip Park will provide a long-term future vision and statutory requirement to fund new district level recreational facilities and amenities.

A staging plan is included in the final masterplan following confirmation of \$1.15m funding from the NSW Public Spaces and Legacy Program 2020-22 to implement stage 1 of the masterplan.

Stage 1 (2021/2022) includes the below provisions:

- New district playground (including inclusive accessible play, nature play space, ½ court basketball)
- New picnic and BBQ areas, seating, water fountains, waste bins
- New pathway lighting (preferably solar), bike parking
- New landscaping and tree planting

Stage 2 (2025 subject to funding availability)

- Design and construct a water play facility
- Upgrade the existing sports field
- Improve park connectivity/ parking where relevant.

August to September 2021

A second car parking survey will be completed to inform parking requirements associated with the winter seasons sports. This survey was postponed due to COVID 19 health orders that commenced June 2021. A draft concept plan relating to Stage 1 of the Masterplan will be developed using community consultation feedback provided during the masterplan engagement process.

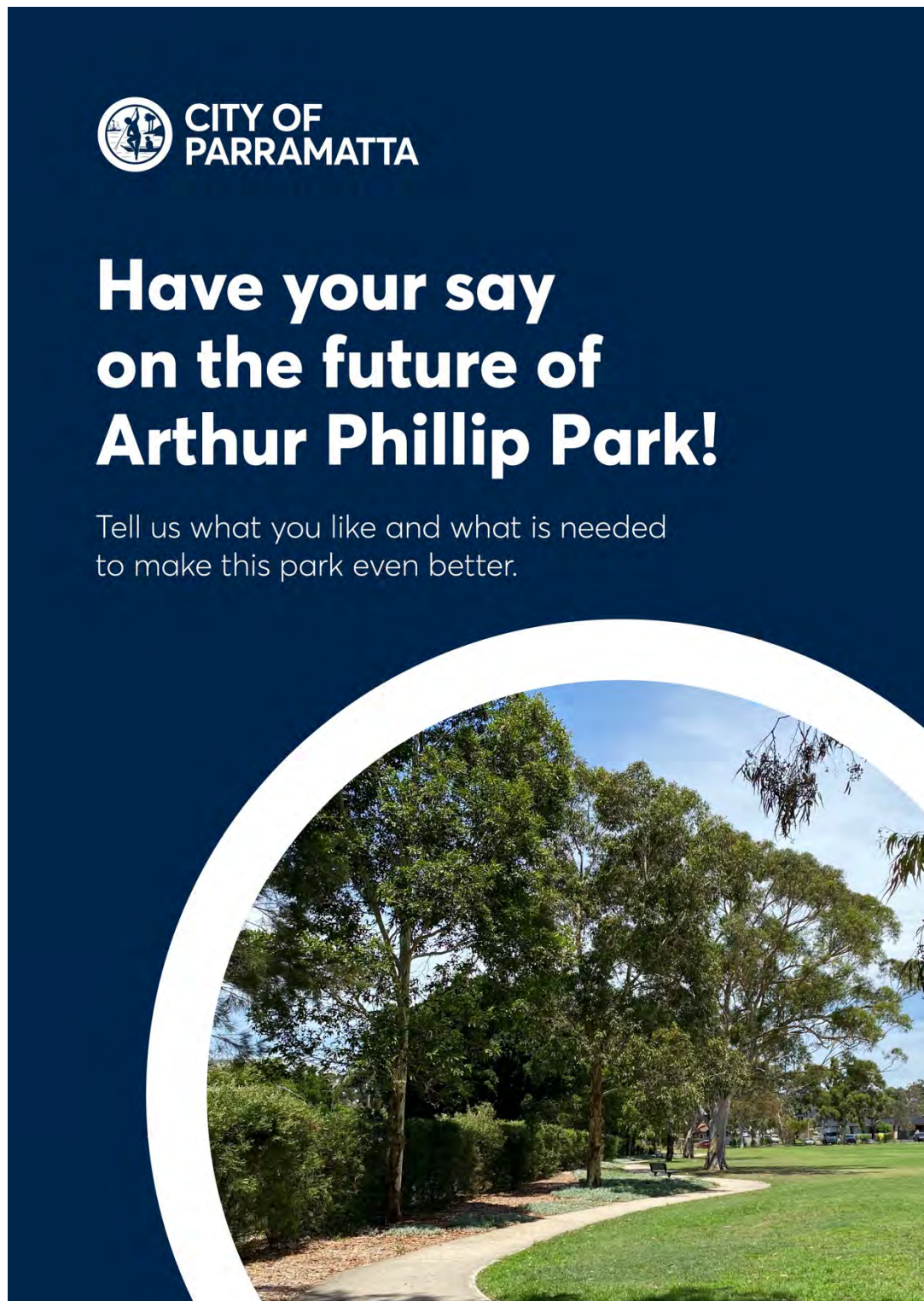
The draft concept plan identifies the park equipment, materials and embellishments that will be used i.e. play equipment, seating, trees etc.

September/October 2021 (dependent on public health orders)

Council will engage further with the community to review the draft Stage 1 concept plan to for each upgraded or new component of the park such as the play spaces, fitness station, picnic and BBQ spaces, carpark, trees and circuit path lighting. Council will use community feedback to refine the draft concept plan before progressing to detailed documentation and construction (mid 2022).

Phase 3 Open Response Comments

The following comments, ideas and feedback were captured in open response questions asked in the Phase 3 engagement, and have been taken into consideration when making any amendments to the draft Master Plan for Arthur Phillip Park.

Do you have any finals comments on the Draft Master Plan?

- Love walking trail, great to see more trees along the track
- The field is fine as it is as it drains well and can be played on when others are washed out
- Please keep parking bollards to stop trucks taking up multiple spots. More trees on the northern side of the south pathway. If regrading field please make sure drainage is adequate. Any timed parking needs to accommodate lengthy stays (4hrs)
- Consider a basketball ring for children, not just adults. More trees around the perimeter. Tennis wall and tennis ball thrower. More water bubblers along the path. Wider walking path with markings for directions to assist dual modes on the paths
- Keep the trees. Shade over the play area. Bee friendly garden. Taps and water access. Basketball for different ages. Tennis. Sound and waterplay. Climbing walls and frames. Path could be more interesting and playful. Plant natives
- Additional parking
- Urgent need for a facility for the general community that can accommodate elderly meeting spaces, youth groups, recreational and hobby groups. This could replace the child care centre as there are many such commercial facilities in the area
- Thank you. If it could be sped up that would be great
- Small garden for growing vegetables with kids. Coffee shop
- Solar lights
- I suggest that the parking time be four hours
- Yes the master plan is good, however I think the phase 2 development may not be required and also the development should be evenly distributed throughout the park. It is crowded only on Redbank Road side
- Playground for kids with activities and water park will be great ideas.
- I have one through the Master plan, really happy for the parking survey undertaken and I totally support the survey. There is no future need of any parking spaces, Also recommendations for No stopping signs on Redbank road and 6 parking spots (to be marked and rear side parking) are very much true.
- I also do support point no. 3 Accessible ramp walkway.
- However I am strictly against any changes especially to the height of the main building (I did not notice the same in current master plan)"
- I see no need or value in water park section.
- Bigger water play park and kids play area
- Local residents main use of the park is as a leisure walking circuit. This experience could be enhanced with more native gum trees, both for shade and heat reduction; and greater natural connections encouraging relaxation and revitalization. There are lawn spaces which could be planted without impacting sports fields. Also more trees / mid level shrubs round exterior
- I would really like to see cricket nets added. We play soccer, AFL and cricket in the Hills and there seems to be a shortage of cricket nets and fields.
